Dear Sir,

I appeal to you as the owner of the domain chrysler-club.net, while the web site at this address (the site is part of www.auto-moto-klub.cz). I do not know if you are aware of the current situation that occurred on this site. There was a significant escalation, which was mainly due to the behavior of administrators (unfortunately I do not know their names, despite repeated calls, I imagined technically have "inraj" and especially "sttv").

The essence of the problem I see is that established the official club called "Club Chrysler axes Czechoslovakia." Since it is an official Department of the Interior approved the association, it is necessary that today could the members of this association and the Internet to act in some cases in a completely enclosed space, and because your site are also registered "members" who, with official club have nothing to do, I asked the administrator INRA (Hans?) if he would go on the web to set access to it separate committee meetings as the club was possible. We wanted it because the site we communicate quite well, a community of people - in terms of really aktivních - is pleasant, so I wanted to agree on further cooperation with the official unofficial club. I was saying, announced that the settings can not be done. So the only option for the club was officially set up their own site. However, the fact that we have users on your site who do not want to be members of an association official, promised that we will continue actively to the original site, so that outsiders do not lose continuity with events at the club.

Because the association is not closed to non-members can participate in events, etc. . just can not take advantage of that club to agree, but it is perhaps understandable.

The only problem caused me to see that my failure to disclose an unwillingness of administrators - in one paragraph article. The article was about 5 minutes deleted and removed my right to create articles. However, after a few message with inraj we explained problem and agreed to the correctness and cooperation. Inraj I promised to talk about it as the "boss of it all here" - I assume that probably with you, but I learned a few days, the chief thing dismissed. Then I asked INRA to contact the boss, because I think that as chairman of the official club boss I could possibly either by phone or in person to explain everything and agree on possible cooperation to each other aychom shooting its own foot.

I was quite surprised when, instead of inraj I wrote "sttv", which is signed only "admin" and supposedly speaks for you and after a few messages I was invited to leave your site. I will not deal with all communications, if you would be interested, I have it all stored off site, because apparently I have to reckon with unexpected deleting my account. And today called for the departure of other members of the official club. Sorry, but we call it "behavior řeznickýho dog". Without explanation, simply from the position of one who has the greater right, I can write anything, but I think it even does not read, just decided.

Finally, it is blocked enter the address of the official web site as a forbidden text. I think all this is totally counterproductive, clubs can easily coexist and cooperate. The official site has a link on the front page of the unofficial club, as well as to your website could have a link to the official. Sites do not compete, the official website to woo you or anyone other advertisers, it is not profitable. And note that due to the fact that the club did not make any official action against your site, it can be considered as the blocking censorship and defamation of the official club. I'd hate to resort to the fact that we deal with these things the official way and I hope it is not in your interest.

I wanted you to talk about the matter rationally and to agree on some way out of this unpleasant situation. However, the mobile number that you have specified the domain registrars, and no one answering the phone line does not exist. Therefore, I choose this form letter, because I fear if you're not familiar with the behavior of your employees. Believe me, I'd rather politely speaking, business owners normally do not write and do not on the behavior of employees, but
